× The school provides students from F1 to Year 13, with a school bus service after payment of the required bus × fees. Students from F1 and F2 can only use the bus service after the "Bus Service Regulations for EYFS Students Agreement" has been signed by Parents.

× The School bus is only provided for students who have completed the required bus registration form. Students × that have been registered in advance will be given priority ×

Bus fees are revised annually. Please check with Admissions Office for more information. ×

× Students must abide by the direction of the bus Monitor at all the times and not create trouble that may disturb x x the driver and other students. Students who do not behave appropriately on the bus will be verbally reminded × 2 times and on the third occasion will be reminded by written letter from the school. The School has the right x x to refuse students who behave inappropriately, and the bus fee will not be refunded. Any damage caused by × students on the bus must be paid by the Parents.

School buses are not available for collecting students attending either an early or late activity. The School bus x x departs daily at 3:15pm. In addition, we have a bus at 4:15pm on Mondays, Wednesdays and Thursdays. Parents will x x need to collect their children from any activity that finishes after 4:15pm. ×

× Should your house/apartment be situated in a small side alley or dead end, we would appreciate it if you could × assist us by having your children meet the school bus at the entrance to the alley. ×

× × On days when children are not attending activities, they are required to take the normal 3:15pm bus directly after × × school. Should a child decide to remain at school for reasons other than attending activities, there is a chance that × × they will be refused a seat on the later bus as these may have already been reserved for the children attending activities. × ×

× Children must remain seated and wear their seat belts at all times. The bus will not move if any student does not x x wear their seat belt. x x

× × In case a student does not attend school for any reason, parents should call the Monitor and email school as early x x as possible. If a student does not want to go home by bus, this must be approved by parents and parents must x x inform the school by email in advance, not by phone. x x

Children should be ready at least 5 minutes prior to the actual collection time. The bus will not wait after the × arranged collection time has passed 2 minutes. Should a child miss the bus, it will be the parents' responsibility to x x arrange alternative transportation to school. x x

× Afternoon: ×

- For students who do not have CCAs, school bus will depart at 3:15pm. × ×
- For students who have CCAs, school bus will depart at 4:15pm. x x
- The buses are on a tight schedule and have to leave at these times to avoid bad traffic in rush hours in the afternoon; x x therefore, please kindly remind your child(ren) to make sure they get on the bus on time. x x
- x x For special reasons, please kindly inform our bus monitor or bus coordinator in advance by contacting hotlines: 0988 47 86 46 or sending emails directly to: busservice@bishanoi.com. In this case, non-CCA buses will wait until x x 3:25pm and CCA buses will wait until 4:25pm at the latest. x x
- × × Kindly note that students who do not show up after the above-mentioned time will be required to contact parents × × to arrange transportation to home.
- × × When being dropped-off at home, children must walk carefully behind the bus, directly into their property. Parents × × need to be at home at least 5 minutes before the arranged drop-off time so that children are be met by either their × × parents or their house staff. If there are no adults to receive the children when the bus reaches the child's residence,
- × × the child will be returned to school and the parents will then be required to collect them from the school office. × ×

 Children must remain seated and wear their seatbelt at all times in the bus.
 Children must abide by the directions of the school bus monitor at all times.
The bus monitor is responsible for all students on the bus, not only my child.
 Children must be ready to be picked up at the indicated time and must be accompanied by an adult during pick-up and drop-off.
Should my child not agree to go on the bus and the monitor is not able to persuade him/her, the monitor can refuse to pick him/her up on that day.
 Parents are responsible for informing the school in case the child cannot use the bus service on a given day.
I will not place responsibility on the school if my child is hurt on the school bus for reason of not being seated next to the bus monitor because I understand that the bus monitor is responsible for supervising all children on the school bus at all times.
