## WITHDRAWAL FORM 2024-2025

## For New Students (in their first year at the School)

If the Student is not returning to the School for the 2024-2025 academic year a Withdrawal Form must be received by the School by the re-enrollment deadline.

## For Re-Enrolled Students (those who have been in school for more than one academic year)

A full term's notice of a Student's leaving is required. A Withdrawal Form must be received by the School by the following dates for the Paying Party to be released from the Agreement. The refundable deposit shall be returned within 30-60 days of the Student leaving the School, after deduction of any arrears of fees and expenses owing for the Student, provided the Withdrawal Form is received on time. If notice is received after the dates below, Paying Party is liable for the following term's full fees. Please refer to the 2024-2025 Student Enrollment Agreement for complete terms.
