- Ensure that places and methods of work are safe and healthy through the arrangements set out in **appendix 1**.

- Protect all children and adults from any foreseeable hazards on BIS campuses or when in the care of BIS staff such as, expeditions and trips.
- Ensure adequate training, instruction, supervision and information is given for all to work and learn in a healthy and safe environment.
- Encourage a culture where everyone takes responsibility for the H&S of all at BIS, including the reporting of issues related to H&S to the relevant H&S representatives on each site.

SCOPE

This policy is endorsed and adopted by the school senior leadership team and applies to all members of the school community, staff, students and parents. This policy will also be applied to any partner agency working or using the facilities on site at BIS HCMC.

DEFINITIONS AND ACRONYMS USED

Health and Safety (H&S)

A multidisciplinary field concerned with the safety, health, and welfare of people within a community, including facilities.



Expeditions and Trips

Visits away from BIS school grounds with community members, both short day trips and longer overnight stays.

POLICY

BIS HCMC is committed to ensure the health and safety of all in our school community. We commit to ensure all risks are managed effectively by consistent adherence to best practice in relation to health and safety, as outlined in Campus Local Plans for all sections of the school:

- Secondary Campus Plan

In addition to the day to day management of regular campus activities, we have robust emergency and crisis response plans to ensure we can respond to emerging events effectively.
